*******Minutes*******

Mr. Frazier opened the meeting. The board reviewed the July 06 Minutes, Mr. Means made a motion to approve the minutes, Mr. Grossman seconded, and the board voted unanimously to approve. There was no public comment for issues on the agenda.

The board began Old Business. James Wells and David Warren were in attendance from Block-by-Block to present. Mr. Wells is a Vice President for Block-by-Block's southeastern deployments, and Mr. Warren is a current Louisville employee who will serve as the DLMD operations manager. Mr. Warren noted that he intends to start recruiting in mid-August, and is already working on uniforms. The company has spoken to LexPark re: operations space. Block-by-Block intends to begin orienting employees on September 7, and to start live operations on September 12. Mr. Frazier asked that the city set up introductions with local representatives (e.g., Police, Parks). Mr. Grossman discussed the need to monitor private property and ensure that building owners are not negligent. Mr. Warren discussed the service request tracking system that will be in use, which will track daily operations through the software system. The data in the software system will allow for reporting updates to the board. Mr. Frazier then previewed the website with the board, and discussed the launch schedule and URL (DLex.town).

The board then discussed New Business. The board reviewed the situation with two parking spaces on Market Street being used as a trash corral, and discussed options on moving forward with the city. Mr. Frazier suggested that Block-by-Block look at the issue as well. Mr. Frazier then mentioned the September 21st, 6:00 pm public hearing, and invited all board members to attend. The forum will be televised on GTV3, and there will be a presentation and audience Q&A. Mr. Frazier asked the board to consider Advisory Council nominees. The board will take nominations for the Advisory Council, and reconvene with nominations at the September meeting.

The board voted unanimously to adjourn at 9:00 am.
